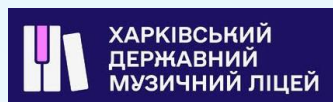

REGULATIONS

OF

III INTERNATIONAL COMPETITION OF PIANISTS NAMED AFTER MARIA AND NATALIYA YESHCHENKO

December 1-7, 2025

1. FOUNDERS

2. PURPOSE OF THE COMPETITION

- 2.1 To preserve and promote the traditions of piano performance schools, with a special focus on popularizing the artistic and pedagogical legacy of the prominent 20th-century Kharkiv piano school representatives – the Yeshchenko sisters: Professor Maria Yeshchenko (PhD in Art Studies) and Professor Nataliya Yeshchenko.
- 2.2 To identify and support talented young pianists, including gifted pupils, students, and postgraduates, as well as to enhance their professional performance skills.

3. COMPETITION PROCEDURE

- 3.1. The III International Competition of Pianists named after Maria and Nataliya Yeshchenko is held both **online** and **offline** on December 1–8, 2025.
- 3.2. All offline-format competition auditions will take place in concert halls within a safe space in the city of Kharkiv;
- 3.3. Online and offline contestants will be evaluated separately by the Jury.
- 3.4. As part of the III International Competition of Pianists named after Maria and Nataliya Yeshchenko there will be master classes of renowned teachers and performers, round tables, recitals by the Jury members, and concerts in memory of Maria and Nataliya Yeshchenko.
- 3.5. Schedule of events:
 - by November 20 (inclusive) – contestant applications will be accepted;
 - by November 30 – applications will be processed by the Organizing Committee of the competition;
 - no later than December 8, 2025 – the results of the competition will be posted on the official website of Kharkiv I.P. Kotlyarevsky National University of Arts, as well as the official *Facebook* web-pages of the University and the Council of Young Scientists.

Competition Schedule for Online Contestants:

- December 1 – Official opening of the competition (on the media channel of Kharkiv I.P. Kotlyarevsky National University of Arts on YouTube);
- December 2-3 – Auditions of contestants for Round I;

- December 4 – Announcement of Round I results;
- December 5-6 – Auditions of contestants for Round II;
- December 7 – Announcement of results and Closing Gala Concert of competition laureates (on the media channel of Kharkiv I.P. Kotlyarevsky National University of Arts on YouTube).

Competition Schedule for Online Contestants:

- December 1 – Official opening of the competition (on the media channel of Kharkiv I.P. Kotlyarevsky National University of Arts on YouTube);
- December 2-3 – Auditions of contestants for Round I;
- December 4 – Announcement of Round I results;
- December 5-6 – Auditions of contestants for Round II;
- December 7 – Announcement of results and Closing Gala Concert of competition laureates.

4. AGE CATEGORIES (as of December 1, 2025)

- **Group 1** – up to 10 years inclusive
- **Group 2** – 11–14 years inclusive
- **Group 3** – 15–17 years inclusive
- **Group 4** – 18–20 years inclusive
- **Group 5** – 21–24 years inclusive
- **Group 6** – 25 years and over

5. TERMS AND CONDITIONS OF THE COMPETITION

- 5.1. To participate in the competition, the following documents must be submitted to the e-mail address of the Organizing Committee at eschenko.piano.competition@gmail.com by November 20, 2025:
 - contestant application in .doc/.docx formats without the contestant's signature, and in PDF/JPG format with the contestant's signature (Appendix 1);
 - colour photo of the contestant;
 - program of performances for both rounds with the indicated timing;
 - photocopy of the first page of the passport or birth certificate;
 - receipt of the registration fee payment;
 - the contestant application serves as a confirmation of consent to the processing of personal data. For underage contestants, the application must be signed by their parents.
- 5.2. **Requirements for submitting video materials by online contestants:**
 - the program for the contestant's competition performance in each round must be recorded **in a single file only**;
 - the contestant's performance must be recorded **exclusively on an acoustic grand piano**;
 - the recording of the competition rounds must be of high quality, **without editing, splicing of pieces, or special effects**;
 - the instrument, hands and face of the performer must be clearly visible in the recording;
 - the recording must be made with a stationary camera in the natural acoustics of the room;

- videos from concerts or other competitions are not allowed;
- video materials must be uploaded exclusively to the competition platform on YouTube;
- when uploading the video to the YouTube platform, **select the option "Not for kids"**;
- the video must be accompanied by a description containing the performer's name, the name of the competition, the year, and the program being performed;
- if the video materials do not meet the requirements, contestants will not be allowed to participate in the competition auditions.

5.3. Starting from April 15, 2025, contestants in the 5th and 6th age categories may select and download one of the specially composed pieces for the competition from the official website of Kharkiv I.P. Kotlyarevsky National University of Arts in the competition section, or contact the organizing committee to receive it via email.

6. FINANCIAL TERMS

6.1. The Organizing Committee of the competition shall set an entrance charitable contribution as follows:

- 30 EUR for foreign contestants in age categories I–III;
- 50 EUR for foreign contestants in age categories IV–VI.

The charitable contribution must be paid by November 20, 2025.

6.2. The charitable contribution is non-refundable.

7. JURIES

- 7.1. Leading musicians, educators, and performing pianists from Ukraine and Europe have been invited to serve on the Jury. The Jury consists of the Chair, members, and the Responsible Secretary. The Responsible Secretary oversees the organization of the Jury's work and participates in its proceedings without voting rights.
- 7.2. The Jury of the competition has the right to:
 - award not all prizes;
 - award one prize to several contestants;
 - award diplomas for the best performance of individual compositions;
 - award diplomas for the best performance of the pieces specially composed for the competition.
- 7.3. The Jury members have the right to decide to terminate the performance if the contestant exceeds the time limit.
- 7.4. The decision of the Competition Jury is final and not subject to discussion, review or appeal.
- 7.5. In all uncertain situations, the Chair of the Jury has the deciding vote.

8. AWARDS

- 8.1. According to the Jury's decision, the contestants receive:
 - **Grand Prix** diploma, which grants the opportunity to perform with a symphony orchestra in the Great Hall of Kharkiv I.P. Kotlyarevsky National University of Arts (subject to the end of the war) or at other concert venues in Ukraine.
 - **I, II, III, IV, V prizes** – laureate diplomas;
 - **diploma winners** of the competition receive a Diploma.All contestants who have not been awarded the title of laureate or diploma winner receive a Certificate of Participation for Round 1 or Round 2.
- 8.2. The Council of Young Scientists of the KhNUA may establish special prizes for the winners of the competition.
- 8.3. The Charitable Foundation of Maria Yeshchenko may award special prizes to the 1st prize winners in each age group.
- 8.4. The Charitable Foundation of Maria Yeshchenko may award a 'Special Prize' to the contestants in the 5th age group for the best performance of L. van Beethoven's Sonata and F. Chopin's Etudes.
- 8.5. The Jury will establish a special prize for the best performance of a piece specially composed for the competition for contestants in the 5th and 6th age categories.

9. PROGRAM REQUIREMENTS

- 9.1. The competition for age category 1 is held in two rounds, with the first round taking place at the educational institution.
- 9.2. The competition program for age categories 2, 3, 4, and 5 includes two rounds.
- 9.3. No less than 50% of the total number of contestants in the first round will proceed to the second round.
- 9.4. The entire program must be performed by the contestants exclusively from memory.
- 9.5. Program requirements:

Age category 1 (up to 10 years inclusive)

Round I – internal selection of contestants, which is held at the educational institution with mandatory inclusion of the contestant(s) in the Meeting Minutes. The minutes are stored at the educational institution where the contestant studies.

Round II (playing time up to 10 minutes)

Free program of the contestant's choice.

Age category 2 (11–14 years)

Round I (playing time up to 10 min):

- a) a polyphonic composition by J.S. Bach;
- b) an etude of the contestant's choice.

Round II (playing time up to 10 min):

2 compositions of different character, with the compulsory performance of a piece by a composer from the contestant's country.

Age category 3 (15–17 years)

Round I (playing time up to 15 min):

- a) a prelude and fugue from *The Well-Tempered Clavier* by J.S. Bach, or a harpsichord suite by a Baroque composer;
- b) a virtuoso etude of the contestant's choice;
- c) a composition by a composer from the contestant's country.

Round II (playing time up to 20 min):

- a) the first movement of a classical sonata by J. Haydn, W. Mozart, or L. van Beethoven;
- b) a composition from the Romantic era;
- c) a composition from the 20th -21st centuries.

Age category 4 (18–20 years)

Round I (playing time up to 20 min):

- a) a Baroque composition (or compositions) of the contestant's choice;
- b) a virtuoso etude of the contestant's choice;
- c) a composition by a composer from the contestant's country.

Round II (up to 25 min):

- a) 1 or 2, 3 (4) movements of a classical sonata by J. Haydn, W. Mozart, or L. van Beethoven;
- b) a composition from the Romantic era;
- c) a composition from the 20th-21st century.

Age category 5 (21–24 years)

Round I (playing time up to 25 min):

- a) a polyphonic composition by J.S. Bach;
- b) a virtuoso etude of the contestant's choice;
- c) a composition of the contestant's choice;
- d) one piece of the contestant's choice from the list of specially composed works for the competition: Anatolii Haidenko "Ukrainian Rhapsody" or Dmytro Malyi "Vesnianka". The sheet music can be downloaded from the official website of Kharkiv I.P. Kotlyarevsky National University of Arts in the competition section or via the QR code:



Round II (playing time up to 30-45 min):

- a) a classical sonata by a composer from the Classical era (performed in full);
- b) a long-form composition from the Romantic era (medium or large form, individual movements may be performed);
- c) a composition from the 20th-21st century.

Age category (25 years and older)

Round I (up to 30 min):

- a) a polyphonic composition by J.S. Bach;
- b) a virtuoso etude of the contestant's choice;
- c) a composition of the contestant's choice;
- d) one piece of the contestant's choice from the list of specially composed works for the competition: Anatolii Haidenko "Ukrainian Rhapsody" or Dmytro Malyi "Vesnianka". The sheet music can be downloaded from the official website of Kharkiv I.P. Kotlyarevsky National University of Arts in the competition section or via the QR code:
